CHAPLAIN'S REPORT

Greetings Marines!

There is an interesting verse in the Book of Exodus which says, "But Moses said to God, 'Who am I, that I should go to Pharaoh, and that I should bring the sons of Israel out of Egypt?' And He said, 'Certainly I will be with you..'"

I want to compare this great Prophet of Israel with a modern-day Church Leader: Dwight L. Moody (the founder of Moody Bible Institute in Chicago). There was a reason that Mr. Moody (1837-1899) led more people of of spiritual bondage into freedom in Christ than any other evangelist of his day; traveled more than a million miles in ministry; spoke to more than 100 million people; established schools for boys and girls; a Bible Institute for the training of ministers; and publishing houses for the printing of evangelistic materials. But the reason was not because of his background, training, or eloquence.

Dwight Moody was one of nine children under the age of 13 left fatherless by the death of his alcoholic father. With only a fifth grade education he left home to work in a shoe store in Boston. Because he was spiritual illiterate, he was denied church membership. So, he began to educate himself in the Scriptures, and he advanced in business. He eventually began to preach the gospel. In 1873 a friend in England challenged him with what has become Moody's signature quotation: "The world has yet to see what God can do with a man fully consecrated to him." Moody's response: "By God's help, I aim to be that man." God's help was the reason behind the accomplishments of Dwight L. Moody.

Another man, born of even more humble means, discovered the same thing Moody did—but in a different way. Born a slave in Egypt, Moses grew up in poverty under the tyranny of Pharaoh until he escaped to the land of Midian. There, God called him to lead the rest of the Hebrews out of bondage into Freedom. But Moses protested, saying he was not eloquent enough to speak God's words for Him.

"I made your mouth," God responded. "Therefore, I will help you to speak. I will teach you what to say when you need to say it." (Exodus 4:11-12). And God did exactly that.

Moses and Moody—both born in humble circumstances, both helped by God to accomplish great things for him. None of us are born without need of God's help; it's just a matter of discovering where we need it most. Seeing the need for help, then God's willingness to give it, are the secrets to being used by Him.

Marines are trained to be self-sufficient, yet interdependent on members of his team or unit. Self sufficiency is simply confidence in our training. Interdependence is reliance on the same training in others.

The USMC enjoys the highest degree of camaraderie of any branch of the U.S. Military. We are legendary in our spirit of brotherhood (once a Marine....), right? We, like Moses and Moody, come from humble beginnings. We join a Band of Brothers, and give and receive help from one another. In combat, that SAVES our lives. In life, we need God's help and the help of the brotherhood.... That ENABLES our lives. I need you, and you need me. I draw strength from that bond, how about you?
