- ( ) The Application received **was not signed** by the Applicant Block (#12).
- ( ) The Application **was not received** by the Selection Board; However, the School Transcripts were received.
- ( ) The Application and/or Transcripts received by the Selection Board were Post Marked **after the deadline** date of 15, July 2019.
- ( ) The Application received **was not signed** by the Sponsor Block (#16).
- ( ) The Application is missing Sponsors Original Marine Corps League Membership Number in block #17 and/or their Paid Life Membership (PLM) Number in block #18 or if not PLM, then their Annual Dues Expiration Date.
- ( ) The Application did not provide Detachment (or MCLA Unit) information #19, #20 (Name, Number or Location).
- ( ) The Application **was not Certified** in blocks #21 - #24 by the two required Detachment (or MCLA Unit) Officers.
- ( ) The Application was signed (Certified) in blocks #21 - #24 by the Applicants Sponsor or not signed by the two other Detachment (or MCLA Unit) Officers as required.
- ( ) The Signature(s) on the application in block(s) ( ) ( ) ( ) are not "Original Signature(s) or "BLANK".
- ( ) The Transcripts **were not provided** with the Application nor were provided to the Selection Board by the School.
- ( ) **Incomplete Transcripts**; Not all High School Years of Transcripts were received by the Selection Board or were missing the Senior Year Final Semester (Final Quarter) GPA / Grades / Credits earned.
- ( ) The Transcripts received by the Selection Board reported that the Applicants **Cumulative Grade Point Average** (CGPA) (Unweighted) were lower than the required MCL Scholarship **minimum average GPA of 3.0**.
- ( ) The Transcripts received by the Selection Board, are deemed to be "**Unofficial**" for one or more reasons below.
  - ( ) Transcripts "**Marked Unofficial**".
  - ( ) Transcripts received by the Selection Board from the Applicant, were copies and **not the required Original(s)** Official Transcripts.
  - ( ) Document(s) received appears to be a **Student Schedule** or **Grade Report** copied from a School Website.
  - ( ) Transcripts deemed "Unofficial" due to not bearing the Schools Authentic raised or embossed seal or the Schools watermark or signature certifying the document(s) authenticity.

**NOTE:** Transcripts "**Electronically**" sent to the student (Applicant) or downloaded by the Applicant from a Website are no longer deemed to be "Official". Only the Applicant is authorized to have their transcripts seen by or sent to a Third Party (i.e. the Scholarship Selection Board). Official transcripts obtained by the student must be Originals and not replicated (copied). Documents can be sent directly to the Scholarship Committee by the School or the School's authorized Clearinghouse Company, but must be Post Marked on or before the required deadline.
