#### **CLOSE COMBAT**

"For we wrestle not against flesh and blood, but against principalities, against powers, against the rulers of the darkness of this world, against spiritual wickedness in high places." Ephesians 6:12

The word "wrestle" translates "pale" and refers to a contest between two opponents, in which each endeavors to throw the other, and the match is decided when the victor is able to hold his adversary down with his hand upon his neck. The term can be transferred to every individual of faith and to our nation that was founded upon religious principles, and application can be made to our ongoing struggle with the opposing powers of evil. Among the hundreds of books in my library, there are at least three volumes that explain and illustrate fighting techniques, both armed and unarmed, that are designed to overpower the enemy. The first two books use Jujitsu and Judo and they bear the nickname 'dirty' fighting. Close Combat (Line Training), is a U. S. Marine Corps publication, by the direction of Lieutenant General J. E. Rhodes, Marine Corps Combat Development Command. The other book is the well-known classic on physical training and hand-to-hand combat, Combat Conditioning. The two books continue to be the center of debate concerning the foundational approach for modern training. The third volume referred to is the Holy Bible and also gives instructions concerning how to win the battles that we face every day. "...We wrestle not against flesh and blood...." When we are attacked by someone because of our faith, political views, for a perceived injustice, or for no apparent reason at all, we are not to wrestle with that person. Our fight is not with flesh and blood. Our struggle is with the evil forces of the unseen world, and Paul by inspiration of God clearly sets forth the truth in principle, that this would not be the right course to take. The warfare is real, but it is against an enemy that we cannot see. However, we can detect the works of the 'pseudo-god of this world' in ourselves and others. The Marines on Iwo Jima could not see the tunneled enemy, but they saw the effects of their presence lying lifelessly on the beaches. We cannot see the wind, but we can see the effects that it has on the trees. How do we fight in this warfare? Prayer seeks the help of the Lord in this battle. The Bible gives us the right way to act when under attack. Taking this kind of action is directly engaging the enemy and trusting the Lord to take care of the outcome of the conflict. In Romans 12:19, the Apostle Paul says, "Dearly beloved, avenge not yourselves, but rather give place unto wrath: for it is written, Vengeance is mine; I will repay, saith the Lord."

The following are those with whom we are engaged in close combat. When one crisis is over, we move on to a different one, because the struggle is ongoing! Principalities are the evil spirits who have the oversight of nations. They would correspond to the rank of generals. Powers are the privates who are wanting to control the lives of human beings through anarchy, spinning truth and world opinion, and through every other sinister means possible. The rulers of the darkness of this world is an indicative emblem of ignorance, misery, and sin; and no description could be more accurate than that of representing these malignant spirits as ruling over a dark world. Spiritual wickedness in high places are evil spirits that are supposed to occupy the lofty regions of the air, and thence to exert a baleful influence on the affairs of man. "It is against such spirits, and all their malignant influences, that we have been called to contend. In whatever way their power is put forth - whether in the prevalence of vice and error; of superstition and magic arts; of infidelity, atheism, or antinomianism; of evil customs and laws; of pernicious fashions and opinions, or in the corruptions of our own hearts, we are to make war on all these forms of evil, and never to yield in the conflict." Albert Barnes, First Presbyterian Church, Philadelphia, (1830–1868).

The comedian Flip Wilson, used to say, "the devil made me do it." He was right! Satan has a well-organized army, and his soldiers are manipulating circumstances in this world right now. The pain, heartache, suffering, confusion, and all of the tragedies of life are the work of Satan operating in the background. He is the cause of the great problems that exist in the world today.

"Wherefore take unto you the whole armour of God, that ye may be able to withstand in the evil day, and having done all, to stand. Stand therefore, having your loins girt about with truth, and having on the breastplate of righteousness; And your feet shod with the preparation of the gospel of peace; Above all, taking the shield of faith, wherewith ye shall be able to quench all the fiery darts of the wicked. And take the helmet of salva-

tion, and the sword of the Spirit, which is the word of God: Praying always...." Ephesians 6:13-18a

As the world comes unglued with the destabilization of society; the dismantling of law-enforcement; the systematic destruction of our ancient landmarks; the re-writing of our history; imposed double-standards and constant spin from a biased media, the entertainment industry, and Silicon Valley; let God lead in the battles... and keep a good supply of ammunition for backup!
